20. Scenario

Robert was a student of high school in Kigali. Robert realized that on the school's visitation day, because most parents come from far, they do not bring hot foodstuffs for their children. One of the things that students expect to enjoy on visitation day are chapattis. There are no chapattis in the school canteen. Because of the big number of students, he realized that this could be a business opportunity.

He decided to do business by making chapattis to sell to students and parents on visitation day. Robert went to the Headmaster and asked for permission to do this business as a mean of getting money to top up his school fees. The Headmaster accepted. Robert had little money. He sold his radio, but the money required was still not enough. He the borrowed more money from brother.

A day before the visitation day, Robert bought wheat flour, cooking oil, and salt. He also bought a frying pan, some few plates, a knife, a jerrycan and forks. He then went to the nearby trading Centre of Kabuga and asked Juma, who is skilled at making chapattis to come and work for him the following day. He promised to pay him at the end of the day. The following day which was the visitation day, Robert was able to sell over 300 chapattis.

He paid Juma his wage and was able to remain with some money as profit. He then kept the remaining materials and equipment to use the next visitation day because he had decided to continue doing this business every visitation day.
